

CLERGY STATEMENT OF MY RELIGIOUS OBJECTIONS TO THE COVID-19
JOHNSON & JOHNSON, PFIZER, MODERNA, AND NOVAVAX VACCINES

As an ordained Christian minister who has taught the Bible for over forty years, both in full-time pastoral ministry and a non-profit Christian ministry on the Internet, it is clear to me that the Covid-19 vaccines violate God's will revealed in the Bible.

PFIZER, MODERNA, AND JOHNSON & JOHNSON COVID-19 VACCINES

Genesis 1:26 also teaches that God created the human body and its human immune system to function exactly as He created it. These mRNA and Viral Vector Vaccines interfere with the function of the human immune system when they insert genetic code instructions into the cell to direct it to make spike proteins. God's intent was for the DNA within a person's body in a cell nucleus to give genetic code instructions not anything outside the cell. Therefore, this process is a violation of God's will for humanity.

NOVAVAX VACCINE

In Genesis 1, the Bible reveals to us that God made human beings after He had created all the original animals. He made human beings with their human bodies in His image and thus their bodies are sacred and separate from animals. Even though their bodies have genetic similarities, human beings are not descended from animals. They are a sacred and separate creation of God which He intended to keep human beings physically separate from animals. This divine sacred separation is the basis of God's prohibition in Genesis 9:3-6. God gives human beings the right to spill (but not eat) the lifeblood of animals for food, but then prohibits the killing of humans made in the image of God whose lifeblood is sacred to God as part of His image. Also, permission is given by God only to ingest parts of animals (minus the blood) which go through the digestive system and are broken down into nutrients for the human body.

Because of this, I believe that humans are not to receive any transplantation of animal body parts, any animal blood transfusions, or any vaccines that have residual cells of animals in them. This intermingling of animal cells with the human body and particularly its blood apart from digestion I believe is forbidden by God. Therefore, I reject the Novavax vaccine because it was developed using insect (moth) cells and contain their residual DNA and cell proteins.

In this video (starts describing Covid-19 vaccines at 2:09), GAVI states, "Not all vaccines [traditional ones] are designed to introduce antigens to the body. Some work by using cells in a patient's body to produce the antigens themselves. Examples include viral vector vaccines and mRNA vaccines. In both cases, the goal is to get a short fragment of genetic code taken from the target pathogen, in this case the SARS-Cov-2 virus that

causes Covid-19, into the patient's cell. By hijacking the cellular mechanisms, these kinds of vaccines mimic the way viruses normally reproduce during natural infection, but rather than creating copies of the virus, the cells only produce large amounts of antigen that then usually trigger a strong immune response.”

GAVI admits that the cellular mechanisms are hijacked in order to cause the cell to produce antigens. This is an apt description of the interference the genetic code instructions produce in the cell. “Viral Vector vaccines [Johnson and Johnson/Astra-Zeneca] achieve this by inserting the genetic code for the antigen into a harmless virus which effectively acts like a delivery system to get the code into the cells without causing disease.”

“Nucleic Acid Vaccines, like mRNA and DNA vaccines [Pfizer and Moderna] also involve inserting genetic code into cells, to produce antigens. But instead of using viruses to deliver the code, these vaccines take a more direct approach that involve inserting the code directly into cells, either by attaching it to a molecule or by forcing it into cells, using a ‘gene gun.’”

GAVI admits that these vaccines insert genetic code into cells, to produce antigens. God designed the human immune system so that the DNA in the cell would give genetic instructions to the cell rather than genetic code instructions being inserted by human beings from outside the cell. This describes the interference the genetic code instructions produce in the cell.

DOCUMENTATION FOR THE PRESENCE OF ANIMAL DNA AND CELL PROTEINS IN THE NOVAVAX VACCINE FROM FDA FACT SHEET FOR HEALTHCARE PROVIDERS ADMINISTERING VACCINE (p.25):

13 DESCRIPTION

The Novavax COVID-19 Vaccine, Adjuvanted is a colorless-to-slightly yellow, clear-to-mildly opalescent suspension for intramuscular injection that is free from visible particles. Each 0.5 mL dose of the Novavax COVID-19 Vaccine, Adjuvanted contains 5 mcg of SARS-CoV-2 recombinant spike (rS) protein and 50 mcg Matrix-M adjuvant. The Matrix-M adjuvant is composed of Fraction-A (42.5 mcg) and Fraction-C (7.5 mcg) of saponin extracts from the soapbark tree, *Quillaja saponaria* Molina.

The rS protein is produced by recombinant DNA technology using a baculovirus expression system in an insect cell line that is derived from Sf9 cells of the *Spodoptera frugiperda* species.

Each dose of the Novavax COVID-19 Vaccine, Adjuvanted also contains the following ingredients: cholesterol, phosphatidylcholine, potassium dihydrogen phosphate (3.85 mcg), potassium chloride (2.25 mcg), disodium hydrogen phosphate dihydrate (14.7 mcg), disodium hydrogen phosphate heptahydrate (2.465 mg), sodium dihydrogen phosphate monohydrate (0.445 mg), sodium chloride (8.766 mg) and polysorbate 80 (0.050 mg), and Water for Injection. The pH is adjusted with sodium hydroxide or hydrochloric acid.

Each 0.5 mL dose of the Novavax COVID-19 Vaccine, Adjuvanted may also contain residual amounts of baculovirus and Sf9 cell proteins (≤ 0.96 mcg), baculovirus and cellular DNA (≤ 0.00016 mcg), lentil lectin (< 0.025 mcg), methyl- α -D-mannopyranoside (2 mcg), simethicone (< 0.92 mcg), pluronic F-68 (< 2.19 mcg), Triton X-100 (< 0.025 mcg), and Tergitol (NP9) (< 0.05 mcg).

The Novavax COVID-19 Vaccine, Adjuvanted does not contain preservative.

The vial stoppers are not made with natural rubber latex.
